***Snow and Ice Removal:*** Section 12-2001 of the Borough Code of Ordinances states that “the owner, occupant or tenant of every property fronting upon or alongside of any of the streets in the Borough is hereby required to remove or cause to be removed from all of the sidewalks in front of or alongside of such property all snow or ice thereon fallen or formed, with 24 hours after the same shall have ceased to fall or to form. The owner of a property shall be responsible for conforming to the requirements of this section where such property is occupied by such owner or is unoccupied; the tenant or occupier thereof, where such property is a multiple-business or multiple-dwelling property, occupied by more than one (1) tenant or occupier.” Failure to comply with this Ordinance could result in a fine.
